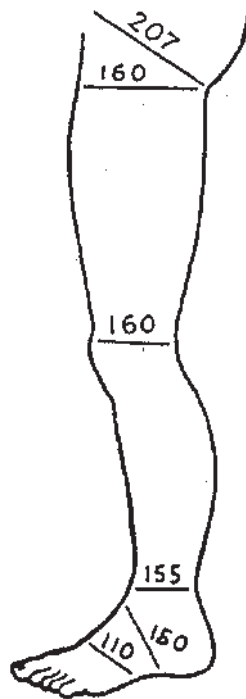
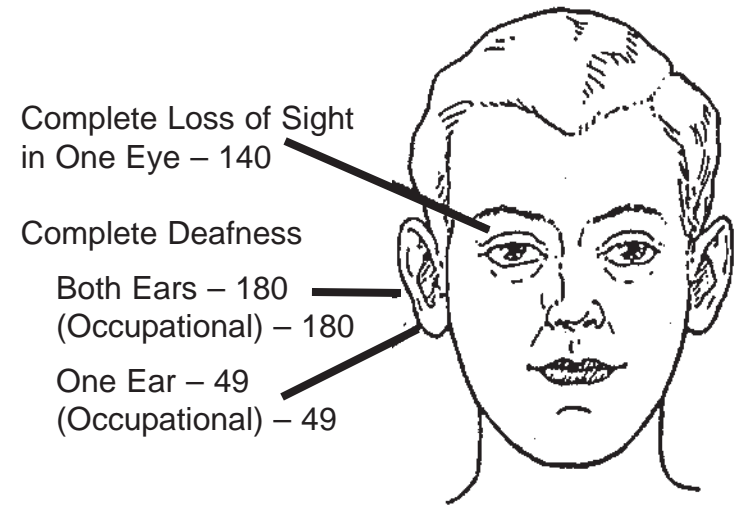
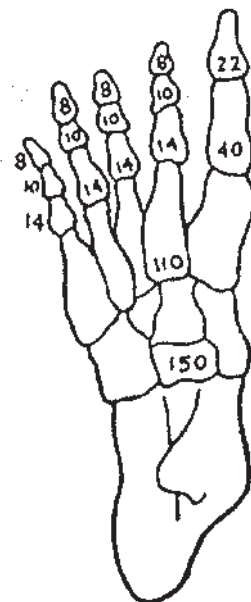


# CHART NO. 1 PERMANENT PARTIAL DISABILITY SCHEDULE

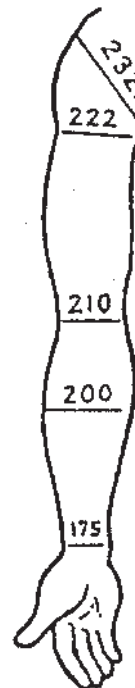

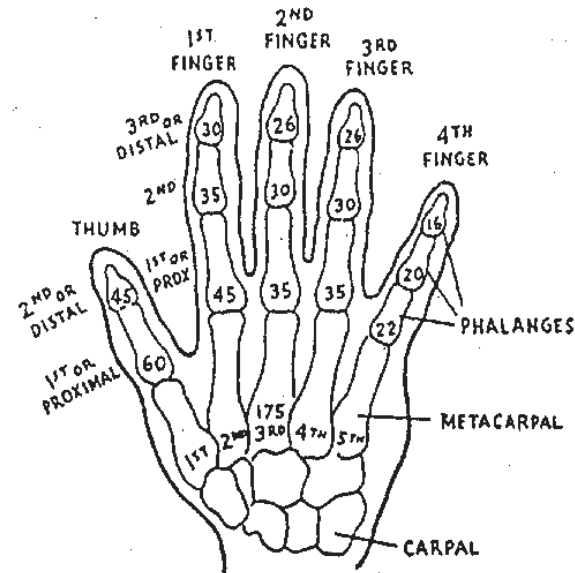

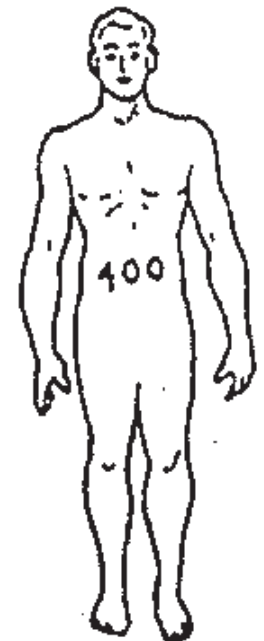
